Notice of Hearing to receive public comment on the proposal by Governor Tate Reeves to redesignate the agency responsible for the administration of the Client Assistance Program (CAP) from the current agency, the Mississippi Society for Disabilities (MSD), to the Mississippi Coalition for Citizens with Disabilities (MSCCD).

CAP is a federally mandated program (34 CFR Section 370), which advises and informs clients and client-applicants of all services and benefits available to them as authorized by the Rehabilitation Act of 1973, as amended 29 U. S. C. Section 732. In Mississippi, these programs are provided through the Office of Vocational Rehabilitation of the Mississippi Department of Rehabilitation Services.

As established by Section 112 of the Rehabilitation Act of 1973 ("the Act"), the purpose of CAP is as follows:

To provide assistance in informing and advising all clients and client applicants of all available benefits under this Act, and, upon request of such clients or client applicants, to assist and advocate for such clients or applicants in their relationships with projects, programs, and services provided under this Act, including assistance and advocacy in pursuing legal, administrative, or other appropriate remedies to ensure the protection of the rights of such individuals under this Act and to facilitate access to the services funded under this Act through individual and systemic advocacy.

The Client Assistance Program shall provide information on the available services and benefits under this Act and Title I of the Americans with Disabilities Act (ADA) of 1990 (42 U. S. C. 12111 et seq.) to individuals with disabilities in the State, especially with regard to individuals with disabilities who have traditionally been unserved or underserved by vocational rehabilitation programs. In providing assistance and advocacy under this subsection with respect to services under this title, a client assistance program may provide the assistance and advocacy with respect to services that are directly related to facilitating the employment of the individual.

CAP is one hundred percent federally funded by the U. S. Department of Education's Rehabilitation Services Administration (RSA) through an annual formula grant to the Office of Vocational Rehabilitation of the Mississippi Department of Rehabilitation Services.

The Governor holds the authority for the designation of the agency responsible for operating CAP in accordance with Section 112 of the Act, as amended. Pursuant to federal regulations, 34 CFR Section 370.2(c), this designation should be to an agency independent of any agency that provides treatment, services, or rehabilitation to individuals with disabilities.

MSCCD is a private not-for-profit state-wide cross-disability organization formed in Mississippi in 1989, composed of Mississippians with disabilities and their families regardless of age, race, gender, sexual orientation, disability, nationality, economic status, or religion, organizations that represent or advocate for people with disabilities, professionals who work in disability-related fields, and other interested citizens. It is the mission of MSCCD to expand opportunities and enhance the quality of life for children, adolescents, and adults with disabilities and their families and empower these individuals to reach their full potential in every aspect of life and to be a voice for families, advocates, consumers, and professionals representing the interests and needs of people with disabilities.

Written or oral submissions must be received no later than 5:00 p.m. on May 9, 2024. The Governor will fully consider all public comments before issuing a written decision regarding redesignation. If there is no opposition to the redesignation, or such opposition is insufficient to outweigh the Governor's good cause and necessity to redesignate the administration of the CAP from MSD to MSCCD, the Governor will issue a written decision redesignating CAP to MSCCD on or after June 1, 2024.
