Summary of 2023 Events

Assets in Mississippi ABLE rose again in 2023 from \$1.7 million in December 2022 to \$2.5 million by the end of December 2023. A total of 83 new accounts were opened in 2023, with most of them being opened online. This brings the total number of accounts in Mississippi to 387 in 2023. The counties with the most open accounts in Mississippi were Simpson, Madison, Desoto, Rankin, Harrison and Hinds.

Throughout 2023, presentations and trainings on the Mississippi ABLE program continued. Mississippi ABLE also continued its "ABLE to Save Month" during August of 2023.

Mississippi ABLE also continued its Town Hall meetings in 2023. The meeting was held in September in Hattiesburg on the campus of William Carey University. The event had about 25 in-person attendees and more than 1,000 were able to attend virtually. Mr. Taylor and Mr. Howard were on WDAM News and SuperTalk Radio to get the word out about the ABLE Town Hall. The Mississippi ABLE team has done a great job at these events interacting with those in attendance and making sure contact information is gathered for each attendee so Mississippi ABLE can continue to keep members of the community informed about the ABLE program.

Ms. Mississippi 2023 Vivian O'Neal and Dwight Owens both partnered with MDRS and used their social media influence and filmed multiple promotional videos for Mississippi ABLE in 2023. Mississippi ABLE advertising was featured in NorthSide Sun newspaper, Parents & Kids Magazine, SuperTalk TV and Delta Magazine ads. The advertising efforts yielded a positive ROI in the community through creating more visibility.

At the May 30, 2023 meeting, the Board was informed that Paul Rogers had been reappointed to serve another term. Rick Courtney was re-elected as Chairman and Chris Howard was re-elected as Vice-Chair for another year at the August 23, 2023 meeting. Kimberly Remak was elected to the Mississippi House of Representatives in 2023 and will no longer serve on the Mississippi ABLE Board.
