# Home and Community-Based Waiver Programs

Independent Living Waiver (IL) & Traumatic Brain/Spinal Cord (TBI/SCI) Injury Waiver provide long-term services and supports to individuals in their homes and communities as an alternative to nursing home care.

Traumatic Brain Injury/ Spinal Cord Injury Trust Fund Program provides direct services to individuals who have sustained a traumatic brain injury/spinal cord injury. Innovative programs are also provided to focus on the awareness and prevention of these conditions.

To qualify for these waivers, individuals must meet the following eligibility requirements\*:

- » Must require Nursing Facility Level of Care
- » Must be medically stable
- » Must be Medicaid eligible \*Additional criteria may apply.



Services provided through this program include:

- Attendant Care
- Specialized Medical
  Equipment and Supplies
- Environmental Accessibility
  Adaptions (Home Modifications)
- Nursing Home Transition
  Assistance
- Respite Care
  (TBI/SCI Waiver only)

To qualify for the Trust Fund, individuals must meet the following eligibility requirements:

- » Must have a severe disability as a result of a traumatic spinal cord injury or traumatic brain injury (not from congenital or medical procedure)
- » Must be a resident of Mississippi
- » Must be medically stable
- » Must not be eligible to receive duplicate services under any other program

Services provided through this program include:

- Transitional Attendant Care
  (12 months or less)
- Specialized Medical Equipment
- Environmental Accessibility
  Adaptions (Home Modifications)
- Vehicle Modifications
- Respite Care



Federal Independent Living Grant

provides funding for solutions that help individuals with disabilities regain more independence in their environments. State Attendant Care provides personal care services to individuals who have severe disabilities and are not eligible to receive these services through other sources. Participants cannot be eligible to receive duplicate services under any other program.

To qualify for this grant, individuals must meet the following eligibility requirements:

- » Must have a severe physical or mental impairment which substantially limits his/her ability to obtain, maintain, or advance in employment or live more independently
- » Must not be eligible to receive duplicate services under any other program

Services provided through this program include:

- Assistive Aids
- Durable Medical Equipment
- Environmental Accessibility Adaptions (Home Modifications)
- Vehicle Modifications
- Orthotics and Prosthetics

To qualify for this program, individuals must meet the following eligibility requirements:

- » Must have a severe physical or mental impairment that causes them to need assistance with their activities of daily living
- » Must not be eligible to receive duplicate services under any other program
